WAIVER

In consideration of being given the opportunity to participate in any **Frisco Rowing Centers** (FRC) activities for the season, I, for myself, my personal representatives, assigns, heirs, and next of kin:

- Acknowledge, agree and represent that I understand the nature of Rowing Activities, both on water and land-based, and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further warrant that I have basic swimming skills.
- 2. Fully understand that (a) rowing activities involve risks and dangers of serious bodily injury, including permanent disability, paralysis, death ("Risks"): (b) these Risks and dangers may be caused by my own actions, or inactions, the actions of others participating in the Activity, the conditions in which the Activity takes place, or the negligence of the Releasees names below. (c) there may be other risks and social and economic losses either not known to me or readily forseeable at this time and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity.
- 3. AGREE and WARRANT that I will examine and inspect each Activity in which I take part as a member of the Club and that, if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the Activity and will refuse to take part in the Activity until the condition has been corrected to my satisfaction.
- 4. HEREBY RELEASE, discharge and covenant not to sue USRowing, FRC, their administrators, directors, agents, officers, volunteers and employees, other participating regatta organizers, any sponsors, advertisers, and if applicable, owners and lessons on premises, on which the Activity takes place (each considered one of the Releasees herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify save and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which may any may occur as a result of such claim.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law

and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect. IN SIGNING THIS DOCUMENT I FULLY RECOGNIZE THAT IF ANYONE IS HURT OR PROPERTY IS DAMAGED WHILE I AM ENGAGED IN THIS EVENT, I WILL HAVE NO RIGHT TO MAKE A CLAIM OR FILE A LAWSUIT AGAINST FRISCO ROWING CENTER MANAGEMENT, ITS OFFICERS, AGENTS, DIRECTORS, AND PRINCIPLES, EVEN IF THEY OR ANY OF THEM NEGLIGENTLY CAUSE THE BODILY INJURY OR PROPERTY DAMAGE.
